Cindy from Erin's House

- Erin's House for Grieving children is in it's 32nd year. This is a beautiful community outreach program that started not from a happy reason, but for a happy outcome. This organization provides services to the community for no cost and receives no federal or state funding. This is a peer support-based outreach where the children range from 3-18 in age who have experienced a death. The children are grouped by age and same death experience.
- Erin's House is working to provide services for ages 19-25 as this is a lost service.
- Their facility is 4500 sq foot building, which is currently in the phase 2 capital campaign.
 - They expect to have their launch and ribbon cutting on the new facility in the beginning of 2025.
- This organization also offers school outreach programming located in NE and SW Fort Wayne. They are in 52 different schools and service 400 children. If a school identifies 5 children in need Erin's house will work with that school's counselors to get the kids services they need.
- Erin's house also provides individual and family camps offsite that can include fun activities such as ropes courses.
- This organization is staffed by 14 adults that help bring outreach to homicide/suicide grief victims throughout community outreach and afterschool programming.
- They reach 2,000-3,000 youth each year

• ESA Foundation

How many of you have heard of the ESA Foundation?
 How many of you would say you have a very strong understanding of what the Foundation does and how?

Let me provide you with some background. The ESA Foundation is a separate financial and tax entity from the ESA Membership Corporation. ESA Foundation (or ESAF) is a non-profit tax-exempt corporation with 501(c)3 status. The ESA Foundation was established in 1970. Its primary mission is to promote education by awarding undergraduate and graduate scholarships and grants to support people changing careers or seeking additional training in their current career field.

It is Scholarship Season! The Foundation offers more than 200 endowed college scholarships for undergraduate and graduate-level students. The application portal opened September 1 and the deadline for application is January 31, 2025. If you know a high school senior, a current college student, a student applying to or currently enrolled in graduate school, please let them know about the ESA Foundation scholarships. ESA members and their family members are eligible to apply for scholarships but receive no special preference in the selection process.

Direct students to www.epsilonsigmaalpha.org/scholarships. There is also a QR code you can scan at my Ways and Means table that will take you directly to the page so you can share by email or text right from your smartphone.

So, where does all this money come from?

The Foundation is funded by donations from individuals, ESA Foundation members, and from annual and ongoing fundraising programs developed by the Foundation.

So, how can you support the ESA Foundation?

Here are a few facts about ESA Foundation membership:

A person does not need to be a member of ESA to become a member of the ESA Foundation.

Membership dues are \$40 annually for individuals and chapters and a Life Active membership is available for a one-time fee of \$500.

- Indiana currently has 30 individual members. Eleven of Indiana's 17 chapters are members, including 2 with Life Active status. The Indiana State Council is also a Life Active member, which reflects well on our state's commitment to the Foundation. Several of you have memberships up for renewal for the end of the year.
- When you become a member of the Foundation and recruit others to join as well, you are helping to support the general operations of the Foundation along with grant programs. As a member, you also have a voice in the election of Directors for the Board of Directors. ESA Foundation elections occur in an online format each year. To be eligible to vote in 2025, your dues (new member or renewal) must be paid by December 31, 2024. Several members are due for renewal between now and the end of the year. If you have been a member in the past but are unsure whether or not you have paid dues this calendar year, you can log into member center, go to "my account", select the option "donate to ESAF" and then select "View my Foundation Giving History" from the drop-down menu. You'll be looking for the item "Annual Dues-Individual" with a date of 1/1/2024 or later. If you would like a visual tutorial, please email me.
- If you are ready to be a member or upgrade your membership to a Life Active membership, you'll log into Member Center and click on "My Account". At the top of the page you'll see ESA and ESAF Membership tab. This is the same tab you click if you are paying your ESA dues online. You will then select the appropriate membership (new, renewing, or Life Active) for Individual or chapter and follow the prompts. If you would like help with this, please don't hesitate to contact me.
- You can also join the Foundation by completing a paper form and sending in a check or credit card information. Be sure to use either the simple or regular contribution form, not the turnaround fund form.

- Other ways to support the Foundation include contributing to the general fund or to a designated fund such as the grant fund or an endowed scholarship fund. You can make these contributions online or by using the donation form available on the Indiana ESA website or the ESA Foundation website www.epsilonsigmaalpha.org/ESAFoundation.
- To ensure you are using the most recent version of the form with ESA's new address on Harmony Road, please only use the forms downloaded from one of these locations.
- I want to remind everyone about the Pathway Program. This is an ongoing fundraiser where anyone (Foundation member or otherwise) can honor a special person (or multiple pavers to honor more than one person) with a gift to the Foundation. Members purchase virtual pavers and the donations help pave the way to a brighter future for our organization, those who follow in our path, and all we serve. This is a great way to honor someone in your chapter, your community, or your family. It could also be a great way to honor an outgoing President or other special chapter member milestone. Flyers are available from me today and are also available on both websites.

Nominations

- Nominations for ESAF Board of Directors are being accepted through October 1, 2023. Directors serve a three-year term. Courtney has placed the nomination form on the Indiana ESA website under the forms then donations or I can email one to you. You can also find this form on the ESA website by visiting the Foundation page.
- Regarding the Foundation website, please don't hesitate to request direct links from me or reach out if you're having trouble finding a particular resource. I too find it difficult to find certain materials quickly on the Foundation page.
- Follow up on Information shared at State Convention regarding the Indiana State Council/Judy and Morton Lester Foundation Scholarship.
- I wanted to follow up on some information I shared at State Convention as I have received some clarification. Every endowment is evaluated each year using a three-year rolling rate, to determine if there are adequate available (or spendable) funds to award the scholarship. This is because a

minimum amount must remain in the account per the endowment terms. Due to market losses and the three-year calculation, our fund did not have adequate funds to award a scholarship in 2024 and one will not be awarded in 2025. I expect to know sometime in October if there will be funds to award a scholarship to someone in the class of 2026.

I am issuing a challenge to my Indiana ESA Family.

I am challenging the chapters who are not members of the Foundation to join.

I am also challenging all board members who are not members of the Foundation to join.

Lastly, I am challenging each of you to become a member of the foundation. Dues are \$40 annually and you'll be supporting the great work of the ESA Foundation.

- Hope for Heroes/Disaster Fund Cindy Norman

 - I want to start by sharing the awards we received at IC in Kansas. I was very honored to accept the following awards on the state's behalf.
 - We received 2023-2024 Net Growth Just 1 More Award
 - o Outstanding Achievement in the area of State's with Net Growth
 - o 3rd Place for Membership Greatest Growth by Number
 - o 3rd Place for Membership Greatest Growth by Percentage
 - Next I want to encourage every chapter to do something for Hopes for Heros. I'm sure there is an event or something you can help with or donate to in each of our communities. There are all kinds of things you can check out on the internet also.
 - The Disaster Fund is just for us. It is a way for ESA to help with unforeseen catastrophic events in our lives, such as a weather even, illness, hospital bill, etc. Up to \$8,000 is available. The forms are on the IC website and you send them directly to the IC Disaster Fund Chairman. You must fill out the form completely and must include copies of all bills you need help with. I hope every chapter can donate to this worthy cause.
 - Now is the time to start watching for the outstanding member in your chapter to be nominated for Member of the Year. I would love to have a candidate from each of our chapters this year.

• I would like to take this opportunity to update everyone on various philanthropic charities currently in progress:

Camp Riley

I met with Melissa Sexton on August 30, 2024, to discuss possible opportunities for Camp Riley this year.

- 1) We discussed the possibility of an ESA Camp Riley Day in late April 2025. This would give the state an opportunity to visit Bradford Woods, take a tour which will include the finalized boat dock we sponsored, as well as a day of service by helping clean up the camp before campers arrive. Please note we are not allowed to visit camp when campers are onsite. This is a rule governed by Indiana University.
- 2) Melisa shared a Wish List for Bradford Woods. I am providing the list with this report. Please note – highlighted items are items that would include naming rights.
