Judy and Morton Lester Endowment Update

Since Fall Conference I have received additional information on the Judy and Morton Lester Endowment. Past IC President Betty Sanders created an endowment – the Judy and Morton Lester Endowment. Betty Sanders and Judy Lester were very good friends. Judy Lester was a great ESA member – she was a member of Beta Kappa and very active in Seymour. Judy was an Indiana State Council President and an International Council President. Judy and her husband Morton brought ESA, Danny Thomas and St. Jude Children's Hospital together. The Lester Endowment has a balance of approximately \$5,966. The minimum balance of the endowment needs to be approximately \$11,110 for a scholarship to be awarded. Anyone, ESA Member or not, can make a contribution to the Judy and Morton Lester Endowment at any time. A total additional

contribution of approximately \$5,144 is needed to fully fund the Judy and Morton Lester Endowment. The Lester estate has not contributed to the endowment. The most recent contribution to the Judy and Morton Lester Endowment was made in 2016 in the amount of \$1,792. In 2004 a very small donation was made to the endowment. There were no contributions made to the endowment between 2004 and 2016. I have been put in contact with John Lester, Judy and Morton's son, regarding the endowment. Mr. Lester is in favor of combining the endowments into one and has asked that his mother's name be acknowledged in the combined endowment.

The ESA Foundation
Scholarship Coordinator has
asked if Indiana would consider
merging the Indiana State
Council endowment with the
Lester endowment to make 1
endowment that would award
one scholarship each year in the
amount of \$800. Betty Sanders

has been contacted regarding this opportunity and is agreeable to merging the two endowments with the understanding that she and the Indiana membership, US, would work together on the criteria for the merged endowment/ scholarship award.

The specific criteria for the Indiana State Council Scholarship and for the Lester Scholarship are the same – the recipient needs to be an Indiana resident; any major; any school with a GPA of 3.0 minimum. The Judging Criteria varies a little bit - Indiana State Council Endowment Judging criteria is category A with Leadership/Service – 20; Financial Need – 35 and Scholastic Ability 35. Category A is posted as Financial Need/Scholastic Ability. The Lester Endowment Judging criteria is a category B with Leadership/Service 15; Financial Need - 50 and scholastic ability 30. Category B is posted as Financial Need. The Category information is what the students will see when they first look at the scholarships on line. Then the students will see the judging criteria.
