On February 24th, the State Executive Board voted on several proposed changes to our Constitution and By-Laws. The changes dealt mostly with a reduction of the required number of committee members, activities no longer followed (such as prohibiting meetings on World Sunday) and general practices we now do. Printed copies were in the chapter presidents' packets at March Spring Conference and with the publication of these changes May edition of the LAMP, Article XV, section 2 of the IN State By-Laws have been fulfilled. I ask chapters to discuss these proposals at their meetings as we will vote on them at June Convention. Bylaw: Article I, section 1

Amended

Now reads: Two Indiana Conferences shall be held each year, one in the fall and one in the spring. There shall not be a Conference held on World-Wide Communion Sunday. Any business requiring the vote of membership may be conducted with each chapter president entitled to one (1) vote. No proxy voting will be allowed.

Change to read: Two Indiana Conferences shall be held each year, one in the fall and one in the spring. Any business

requiring the vote of membership may be conducted with each chapter president entitled to one (1) vote. No proxy voting will be allowed.

Reasons/Comments: Conferences are no longer held on Sunday so there is no potential date conflict with World-Wide Communion Sunday.

Article 1, section 3, sub-paragraph b

Deleted

Now reads: A financial statement will also be sent to the Executive Board for the annual Leadership/Membership Seminar within thirty (30) days following the seminar.

Reasons/Comments: There is no longer a separate Leadership/Membership Seminar.

Article VI

Amended

Now reads: The Junior Past President shall be a member of the Executive Board, responsible for obtaining new rosters from each chapter in good standing postmarked by May 15; be chair for the program "Outstanding ESA Member of the Year"; and be in charge of the Disaster Fund. The Junior Past President shall record the outstanding events while serving as President by inserting a page in the "History of Indiana State Council of Epsilon Alpha" book.

Change to read: The Junior Past President shall be a member of the Executive Board, responsible for obtaining new rosters from each chapter in good standing postmarked by May 15; be chair for the program "Outstanding ESA Member of the Year"; and be in charge of the Disaster Fund <u>and Hope for Heroes</u>. The Junior Past President shall record the outstanding events while serving as President by inserting a page in the "History of Indiana State Council of Epsilon Alpha" book.

Reasons/Comments: Hope for Heroes was added as an International ESA project, and it has fallen to the Junior Past President to report on this project.

Article VIII, section 1

Amended

Now reads: The Nominating Committee shall consist of the first Vice President who shall be Chair and one (1) representative from four (4) other chapters.

Change to read: The Nominating Committee shall consist of the first Vice President who shall be Chair and one (1) representative from three (3) other chapters.

Reasons/Comments: We have less chapters than we did and it is harder to find for (4) people willing to serve.

Article VIII, section 3

Amended

Now reads: The Credentials Committee shall consist of five (5) members.

Change to read: The Credentials Committee shall consist of three (3) members.

Reasons/Comments: Smaller number of members and chapters and rarely need ballots.

Article VIII, section 6

Amended

Now reads: The Constitution and Bylaws Committee shall consist of the Parliamentarian who shall be Chair and one (1) representative from five (5) other chapters.

Change to read: The Constitution and Bylaws Committee shall consist of the Parliamentarian who shall be Chair and one (1) representative from three (3) other chapters.

Reasons/Comments: Less membership and chapters.

Article VIII, section 9

Amended

Now reads: The Chapter Counseling Committee shall consist of the 1st Vice President who shall be the Chair and one (1) representative from six (6) other chapters.

Change to read: The Chapter Counseling Committee shall consist of the 1st Vice President who shall be the Chair and one (1) representative from three (3) other chapters.

Reasons/Comments: Less membership and chapters.

Article X, section 1, sub-paragraph a

Deleted

Now reads: Travel Expense for Executive Board members to executive Board Meetings at the rate of five cents (\$.05) per mile maximum five dollars (\$5.00) per each Board Meeting including parking fees, plus luncheon.

Reasons/Comments: This has not been asked for or paid for several years. It is not in the State Council Budget.

Article XI, section 1

Amended

Now reads: The Indiana State Council President shall represent the Indiana State Council at the International Convention. In the event the President is unable to attend due to illness or family emergency, the following order of representation shall apply: First Vice President, Second Vice President, Treasurer, Junior Past President, and a past Indiana State President. The Indiana State Council shall pay the representative's travel expense, registration fee (including the PICPA Meal), hotel, and or meal expenses.

Change to read: The Indiana State Council Past President shall represent the Indiana State Council as the International Convention. In the event the Junior Past President is unable to attend due to illness or emergency, the following order of representation shall apply, Current President, First Vice President, Second Vice President, Treasurer, and a Past Indiana State President. The Indiana State Council shall pay the representative's travel expense, registration fee (including the PICPA Meal), hotel, and meal expenses.

Reasons/Comments: At the IC Convention you are celebrating the achievements from the past year. Seems appropriate for the immediate Past Indiana President to accept those awards. It has always caused confusion, for instance at the Awards Luncheon, who should be representing Indiana. This small change would clear that up.

Standing Rule Number 6

Amended

Now reads The Executive Board, General Appointments, Chapter Presidents and active members of the Past Indiana President's Auxiliary shall be given a State President's Yearbook, which shall include dates of the Executive Board Meetings, Seminars, Conventions, publication of the LAMP, etc.

Change to read: The Executive Board, General Appointments, Chapter Presidents, and Chair of the Past Indiana Presidents Auxiliary shall be given a State President's Yearbook, which shall include dates of the Executive Board Meetings, Conferences, Conventions, publication of the LAMP, etc.

Reasons/Comments: As cost saving measure, only the Chair of the Past Indiana Presidents Auxiliary shall receive of copy of the State President's yearbook.

Standing Rule Number 9

Amended

Now reads: All Officers and others giving a report shall prepare five (5) copies and submit two (2) typewritten copies of it to the Recording Secretary and one (1) to the President, while retaining two (2) copies for Successor and personal files respectively.

Change to read: All Officers and others giving a report shall prepare copies to email to the Recording Secretary and President and sent prior to meeting, while printing a copy for reading at meeting, printing a copy for the successor file.

Reasons/Comments: Everyone uses email and is asked to send report to the Recording Secretary and President before the meeting. Printing unnecessary copies is wasteful.

Standing Rule Number 16

Delete

Now reads: A Leadership/Membership Seminar is to be held each year with the President acting as Chair.

Reasons/Comments: No longer applicable

Indiana State Council - Judy and Morton Lester Endowments

This article serves as your 30-day notice of an intent for a vote to be taken at State Convention. This article also serves as your notice that this vote will take place on Sunday of State Convention. Please be sure your delegates are available to vote during the third general assembly of the convention on Sunday.

In June at the Indiana State Council Convention a vote will be taken to merge the Indiana State Council Endowment with the Judy and Morton Lester Endowment.

The current Indiana Endowment reads as follows:

Established by the Indiana State Council June 21, 1991. The scholarship was awarded in 1994. Specific Criteria: Indiana Resident/Any Major/any School/GPA 3.00 minimum. <u>Judging Criteria A: Scoring points: Leadership/Service – 20; Financial Need – 35 and Scholastic Ability – 35.</u>

The current Judy and Morton Lester Endowment reads as follows:

Established on March 1, 2003. Specific Criteria: Indiana Resident/Any Major/Any School/GPA 3.00 Minimum. Judging Criteria B: Scoring Points: Leadership/Service – 15; Financial Need – 50; Scholastic Ability – 30.

The vote will be taken on the revised endowment. The revised endowment would read as follows:

Indiana State Council/Judy and Morton Lester Endowment. Specific Criteria: Indiana Resident/Any Major/any School/GPA 3.00 minimum. Judging Criteria A: Scoring points: Leadership/Service – 35; Financial Need – 35 and Scholastic Ability – 20.

Credentials Information

ESAF Credentials will be available at the registration table at the state convention on Friday during convention registration hours. Each ESAF member will need to confirm if they will be attending IC convention or the member will need to have another *ESAF member* carry a proxy vote for them.

If the ESAF member will be attending IC Convention you will need to "Vote" on the form that will be available at state convention.

If the ESAF member is not attending, she should select "Proxy" on the form and list the name of the individual who will carry their proxy vote at IC convention. This MUST be an ESAF member who is eligible to vote in the election.

Chapter and Councils votes are carried as "Proxy" votes. The individuals carrying the proxy vote does NOT need to be an ESAF member. The name of the individual carrying the proxy should be noted on the form that will be available at state convention.

Call for Nominations

While the official nomination period has passed, only two nomination forms were received for the three open positions on the Board of Directors. The ESA Foundation Board is actively looking for additional candidates for this three-year term of 2018 -2021. Per the Foundation bylaws, nominations from the floor will be accepted up to 60 days prior to the annual meeting, therefore there is still time to submit a nomination form.

RECORDING SECRETARY, JENNIFER

Thank you all for a great year! I've really enjoyed being Recording Secretary. I want to share the purpose and importance of a recording secretary and the minutes.

The main duty of the state recording secretary is to keep the minutes for all state board meetings, conferences and conventions. The chapter recording secretaries are to keep the minutes of each chapter meeting.

Taking minutes is an essential part of most meetings. Their purpose is firstly to record action points – what actions have been decided upon, who is responsible and what the milestones/ deadlines are. Secondly, they record summaries of the discussions held at the meeting. Taking minutes is an important job because the minute taker has to follow what can be confusing and inarticulate debates and summarize accurately. Minutes are not word-for-word reports or full conversations.

After the meeting, the minutes should be checked by the president to confirm accuracy and then circulated to all attendees and anybody else affected by any decisions taken at the meeting.

Minutes are required in order to:

keep records of attendance
confirm any decisions made
document voting outcomes
record any agreed actions to be taken
record who has been allocated any tasks or responsibilities
prompt action from any relevant attendees
provide details of the meeting to anyone unable to attend
serve as a record of the meeting's procedure and outcome
